Green Advocacy Academy is inclusive, motivating and educates young activists in the climate debate and advocacy for a sustainable food system.



The first edition of **GAA**, co-financed by the European Union Erasmus+, took place in 2023.
51 people from Poland and Finland took part in 2 national workshops, 5 international meetings and a study visit in Brussels combined with a climate debate, food and green transformation with MPs and Members of the **European Parliament**.

Hope, fear about the future, sometimes doubts Is it worth taking action if so little changes?

- all this is mixed with a large dose of motivation. It is amazing how much these young people are already doing in terms of volunteering, building initiatives and collectives, how much curiosity and openness they haveon other people, on expert people, on accepting knowledge and acquiring new skills.

Participation through advocacy and systemic activism are still not present in school curricula, and climate education remains on the margin, although it should be an element of every subject - because climate, just like human rights and animal rights, permeate every area of life.

Anna Spurek's Comment

Unfortunately, the European Parliament and the Commission still remain in the tightly closed Brussels bubble- incomprehensible and inaccessible to many young people, which means that knowledge is not being built about the EU's decision-making and its impact on our everyday lives.

Green Advocacy Academy opened ours
- REV eyes for the needs of young people,
the need to build knowledge about EU climate
policies, the role of agriculture and the food system
in the climate debate on civic tools for systemic
change.

The fact that many people want to change, share the knowledge they have acquired, change their consumer habits, and want to continue to act shows that we must and have an obligation to include young people in debate and advocacy activism through such projects.

They show us a new perspective of action, new tactics and strategies, and give us hope that together we have the strength to create a future for everyone, alongside politicians and decision-makers.
